The Evolution of Clothing

In this IDAF project we want to write specifically about clothing and uniforms, comparing 1984 according to George Orwell's imagination, today and the future. We will describe these three periods in more detail and show examples to get a better idea of what we imagine. Our goal is to make a project about the topic of clothing and uniforms, which is a topic that is not talked about much, but still affects everyone and will affect everyone in the future.

<u>1984</u>

In the novel "1984" from George Orwell, dress styles are distinguished between Outer Party members, Inner Party members and Proles. Outer Party members, for example Winston and Julia, must wear blue overalls (part 1, chapter 1, p. 4, l. 9). Inner Party members, for example O'Brien, must also wear overalls, but they are black (part 1, chapter 1, p. 13, l. 12). Proles are not required to wear uniforms. [1]



Because both party members wear the same uniform, this creates the illusion that everyone in the party is the same. In fact, nothing could be further from the case. Second, the overalls are ugly, helping to dehumanize party members. [2]

Winston wished to be dressed in blue shorts, grey shirt and red neckerchief of the spies (part 1, chapter 5, p. 64, l. 22 - 26). His opinion was that everyone looked ugly in their uniform overalls (part 1, chapter 5, p.69, l. 13 - 14).

The rich men called capitalists wear long black coats which are called a frock coat, and a queer, shiny hat shaped like a stovepipe, which was called a top hat. This was the uniform of the capitalists, and no one else was allowed to wear it (part 1, chapter 7, p. 84, l. 3-7).

The party members were monitored around the clock and if they did anything that violated the rules, they had to expect penalties. The government brainwashed and manipulated them.

In 2021, everyone can wear what they want. You have every opportunity to follow your own desires, which is something we should really appreciate. However, from school to school, work to work, and country to country, dress codes may differ and yet are not entirely free to choose.

For example, if Cristiano Ronaldo stopped wearing Nike soccer shoes and started wearing Fila shoes, Fila would be much more attractive in the soccer shoe industry. Especially for children, Cristiano Ronaldo is an idol and they want to be like him and that is why they buy the same shoes.

If the clothes are not in line with the latest trends, you are looked at strangely and judged by your appearance. You should not judge anyone by their appearance, but you should expect to be judged based on your looks anyway.



A current topic is the mask regulation of the federation due to COVID-19. Because of these measures one is not allowed to go out of the house without a mask without expecting consequences.

At the beginning of the corona crisis, there were only ordinary blue masks, as known from medicine. Moreover,
